("Special Situations"), (iii) 305,350 shares sold by Global Opportunities Breakaway Ltd. ("Breakaway") in the sale of the shares of Harbinger Group Inc. (the "Issuer") Common Stock (the "Shares") in its registered secondary offering pursuant to the registration statement on Form S-3 filed by the Issuer with the Securities Exchange Commission (Registration No. 333-180070) (the sale described in this (i), (ii) and (iii) the "Reported Transaction"), (iv) 79,319,522 shares retained by Master Fund following the Reported Transaction, (v) 17,446,730 shares retained by Special Situations following the Reported Transaction and (vi) 10,093,637 shares retained by Breakaway following the Reported Transaction.
